Empowering Through Therapeutic Riding

Connor Oakes, Audit Manager based in our Richmond office, serves as a therapeutic riding instructor at Hazelwild Farm in Fredericksburg, VA. She dedicates her time to teaching three lessons a week, servicing approximately 15 riders who face a range of physical and cognitive disabilities.

Enriching Education & Building Community

Katelyn Poffinberger, Tax Supervisor based in our Winchester office, serves as President of the PTO at Evendale Elementary School, where her children attend. Evendale Elementary is a Title I school, serving a significant number of students from lowincome households. Katelyn and her PTO team work to raise funds that enrich the educational experience for all students. They sponsor teacher grants, school assemblies, field trips, and provide essential supplies for the school. Additionally, they organize free community engagement events for families throughout the year.

Honoring History & Unity at YHB
